About this Course

This course meets Building and Energy requirements in Western Australia. This unit of competence specifies the outcomes required to diagnose and repair faults on domestic and commercial Type A gas appliances. Work associated with this unit is undertaken within the scope of AS5601:2013 gas installations and local licensing requirements (gas, electrical and plumbing)

Pre Requisites

- Must have a USI Number (www.usi.gov.au)
- Restricted G Class Training Permit
or
- Full G Class Permit with Installation and have the upgrade endorsement "Servicing of NG & LPG while working under supervision" You will need to contact Building and Energy to apply (6251 2000), applications to Building and Energy can take up to 4 weeks for approval.
- A copy of your permit must be uploaded with your online enrolment
