

# SANITARY – Part of Plumbing Contractors Licence

## About this Course

Plumbing trades persons who have completed a Certificate III in Plumbing (or equivalent qualification) and who have been issued with a Trade Certificate and wish to obtain a license to operate as an Independent Certified Contractor or undertake managerial/supervisory positions within the plumbing industry.

This course is the pre-requisite to undertaking the examination that will satisfy the licensing requirements for a Plumbing Contractor's License issued by the Plumbers' Licensing Board.

The course consists of nine mandatory competencies which are offered as four courses:

1. **Business**
2. **Water**
3. **Drainage**
4. **Sanitary**

## Pre Requisites

- From previous Certificate III in plumbing or can be completed through an RPL process is sufficient evidence is presented
- Must hold a **Plumbing Tradespersons Licence**
- Must have a USI Number ([www.usi.gov.au](http://www.usi.gov.au))
