

# **Gas Servicing**

### **About this Course**

This course meets Building and Energy requirements in Western Australia. This unit of competence specifies the outcomes required to diagnose and repair faults on domestic and commercial Type A gas appliances. Work associated with this unit is undertaken within the scope of AS5601.1:2022 gas installations and local licensing requirements (gas, electrical and plumbing).

### **Pre-Requisites**

\*\*You must upload your <u>Pre-Requisites</u> when you enrol online. You will upload the information under "supporting documents". We will not accept your enrolment without it.

- Must hold a <u>WA Tradespersons Licence</u>
- Must have a USI Number (<u>www.usi.gov.au</u>)
- Full G Class Permit with Installation and have the upgrade endorsement "Servicing of NG & LPG while working under supervision" You will need to contact Building and Energy to apply (6251 2000), applications to Building and Energy can take up to 4 weeks for approval.
- A copy of your permit <u>must be uploaded</u> with your online enrolment
- CPCPCM2043 Carry out WHS requirements\*
- CPCPGS3053 Disconnect and reconnect Type A gas appliances\*

\*From previous Certificate III in plumbing or can be completed through an RPL process during the course if sufficient evidence is presented.

All students will be emailed a 'Student application kit' for the RPL for the two pre-requisite units and it should be completed, if required, before the commencement of the class.
