

# **BACKFLOW PREVENTION**

## **About this Course**

This unit of competence specifies the outcomes required to test, commission and maintain backflow prevention devices in water services. Upon successful completion you will be given a registration number and will be authorised to lodge the required test reports for backflow devices.

# **Pre-Requisites**

- Must hold a Plumbing Tradespersons Licence
- Must have a USI Number (<u>www.usi.gov.au</u>)
- CPCPCM2043 Carry out WHS requirements\*
- CPCPWT3027 Install backflow prevention devices\*

\*From previous Certificate III in plumbing or can be completed through an RPL process during the course if sufficient evidence is presented.

All students will be emailed a 'Student application kit' for the RPL for the two pre-requisite units and it should be completed, if required, before the commencement of the class.

- 45° Triangle
- Correction tape
- Flat scale ruler (1:50 & 1:100 & 1:200)

- Pilot 0.2mm Non-Gel Pens (Red, Green, Blue & Black)
- Calculator
- A4 Notebook
- Steel Toe Work Boots

### **Units Delivered**

- CPCPWT4022 Commission and maintain backflow prevention devices
- Included in the 3 day delivery is an opportunity for the RPL process to occur for those that require it at a time organised during the course.
