

DRAINAGE – Part of Plumbing Contractors Licence

About this Course

Plumbing trades persons who have completed a Certificate III in Plumbing (or equivalent qualification) and who have been issued with a Trade Certificate can use a successful outcome of this course to become a licenced Drainer within the plumbing industry.

To obtain a full plumbing contractors licence skill set please be prepared to enrol in all of the following courses in any order of preference;

1. Business
2. Water
3. Drainage
4. Sanitary

Pre-Requisites

- Completed Certificate III in plumbing (or can be completed through an RPL process if sufficient evidence is presented)
- Must hold a **Plumbing Tradespersons Licence**
- Must have a USI Number (www.usi.gov.au)

Before Class

Please be prepared to allocate some of your own time to complete some online learning and questionnaires. The link and instructions will be sent to you with confirmation of enrolment. **It is a requirement before you enter the classroom that you have completed at least 80% of this learning.** This pre-course content is designed to expose you to the relevant information that will assist you towards attaining the expected level of competency by the end of the course.
